**3. HAZARDS IDENTIFICATION**

<b>Emergency Overview</b>	
<b>Appearance and Odour</b>	: Black. Semi-solid at ambient temperature. Slight hydrocarbon.
<b>Health Hazards</b>	: High-pressure injection under the skin may cause serious damage including local necrosis.
<b>Safety Hazards</b>	: Not classified as flammable but will burn.
<b>Environmental Hazards</b>	: Harmful to aquatic organisms, may cause long-term adverse effects in the aquatic environment.

**Health Hazards** : Not expected to be a health hazard when used under normal conditions.

**Health Hazards Inhalation** : Under normal conditions of use, this is not expected to be a primary route of exposure.

**Skin Contact** : Prolonged or repeated skin contact without proper cleaning can clog the pores of the skin resulting in disorders such as oil acne/folliculitis.

**Eye Contact** : May cause slight irritation to eyes.

**Ingestion** : Low toxicity if swallowed.

**Other Information** : High-pressure injection under the skin may cause serious damage including local necrosis. Used grease may contain harmful impurities.

- Signs and Symptoms** : Local necrosis is evidenced by delayed onset of pain and tissue damage a few hours following injection. Oil acne/folliculitis signs and symptoms may include formation of black pustules and spots on the skin of exposed areas. Ingestion may result in nausea, vomiting and/or diarrhoea.
- Aggravated Medical Conditions** : Pre-existing medical conditions of the following organ(s) or organ system(s) may be aggravated by exposure to this material: Skin.
- Environmental Hazards** : Harmful to aquatic organisms, may cause long-term adverse effects in the aquatic environment.
- Additional Information** : Under normal conditions of use or in a foreseeable emergency, this product does not meet the definition of a hazardous chemical when evaluated according to the OSHA Hazard Communication Standard, 29 CFR 1910.1200.

**4. FIRST AID MEASURES**

- General Information** : Not expected to be a health hazard when used under normal conditions.
- Inhalation** : No treatment necessary under normal conditions of use. If symptoms persist, obtain medical advice.
- Skin Contact** : Remove contaminated clothing. Flush exposed area with water and follow by washing with soap if available. If persistent irritation occurs, obtain medical attention. When using high pressure equipment, injection of product under the skin can occur. If high pressure injuries occur, the casualty should be sent immediately to a hospital. Do not wait for symptoms to develop. Obtain medical attention even in the absence of apparent wounds.
- Eye Contact** : Flush eye with copious quantities of water. If persistent irritation occurs, obtain medical attention.
- Ingestion** : In general no treatment is necessary unless large quantities are swallowed, however, get medical advice.
- Advice to Physician** : Treat symptomatically. High pressure injection injuries require prompt surgical intervention and possibly steroid therapy, to minimise tissue damage and loss of function. Because entry wounds are small and do not reflect the seriousness of the underlying damage, surgical exploration to determine the extent of involvement may be necessary. Local anaesthetics or hot soaks should be avoided because they can contribute to swelling, vasospasm and ischaemia. Prompt surgical decompression, debridement and evacuation of foreign material should be performed under general anaesthetics, and wide exploration is essential.

**Additional Information** : Due to the product's semi-solid consistency, generation of mists and dusts is unlikely to occur. Shell has adopted as Interim Standards the OSHA Z1A values that were established in 1989 and later rescinded.

**Biological Exposure Index (BEI)**  
No biological limit allocated.

**Exposure Controls** : The level of protection and types of controls necessary will vary depending upon potential exposure conditions. Select controls based on a risk assessment of local circumstances. Appropriate measures include: Adequate ventilation to control airborne concentrations. Where material is heated, sprayed or mist formed, there is greater potential for airborne concentrations to be generated. Define procedures for safe handling and maintenance of controls. - work clothing and protective equipment to remove contaminants. Discard contaminated clothing and footwear that cannot be cleaned. Practice good housekeeping.
- Personal Protective Equipment** : Personal protective equipment (PPE) should meet recommended national standards. Check with PPE suppliers.
  - Respiratory Protection** : No respiratory protection is ordinarily required under normal conditions of use. In accordance with good industrial hygiene practices, precautions should be taken to avoid breathing of material. If engineering controls do not maintain airborne concentrations to a level which is adequate to protect worker health, select respiratory protection equipment suitable for the specific conditions of use and meeting relevant legislation. For short-term/splash protection we recommend the same, but recognise that suitable gloves offering this level of protection may not be available and in this case a lower breakthrough time may be acceptable so long as appropriate maintenance and replacement regimes are followed. Glove thickness is not a good predictor of glove resistance to a chemical as it is dependent on the exact composition of the glove material.
  - Eye Protection** : Wear safety glasses or full face shield if splashes are likely to occur.
  - Protective Clothing** : Skin protection not ordinarily required beyond standard issue work clothes.
  - Monitoring Methods** : Monitoring of the concentration of substances in the breathing zone of workers or in the general workplace may be required to confirm compliance with an OEL and adequacy of exposure controls. ### 12. ECOLOGICAL INFORMATION

- Acute Toxicity** : Poorly soluble mixture. May cause physical fouling of aquatic organisms. Expected to be harmful: LL/EL/IL50 10-100 mg/l (to aquatic organisms) LL/EL50 expressed as the nominal amount of product required to prepare aqueous test extract.
- Mobility** : Semi-solid under most environmental conditions. If it enters soil, it will adsorb to soil particles and will not be mobile. Floats on water.
